

REQUEST FORM UNDER THE PROTECTION OF PERSONAL DATA LAW NO.6698

1. General Information Regarding Your Application Right

As a data owner, in accordance with Article 11 of the Personal Data Protection Law No. 6698 ("Law No. 6698"), Tez İleri Teknolojiler ve Savunma Sanayi Tic. Ltd. Şti. ("Company"), you can make the following requests:

- (1) Learning whether your personal data is being processed,
- (2) Requesting information regarding if your personal data has been processed,
- (3) Learning the purpose of processing your personal data and whether they are used appropriately for their purpose,
- (4) Learning the third parties to whom your personal data has been transferred domestically or abroad,
- (5) Requesting correction of your personal data in case of incomplete or incorrect processing, and requesting notification of the transaction made within this scope to third parties to whom personal data have been transferred,
- (6) Requesting the deletion, destruction or anonymization of your personal data in the event that the reasons requiring its processing disappear, even though it has been processed in accordance with the provisions of Law No.6698 and other relevant laws, and requesting notification of the transaction made within this scope to third parties to whom personal data has been transferred,
- (7) Objecting to the emergence of a result against you by analyzing your processed data exclusively through automated systems,
- (8) Requesting the compensation of the damage in case you suffer damage due to the illegal processing of your personal data.

Our company will finalize your application as soon as possible and within thirty (30) days at the latest, depending on the nature of the request, based on Article 13 of Law No. 6698.

2. Application Method

In accordance with Article 13 of Law No. 6698 and Article 5 of the Communiqué on Application Procedures and Principles to Data Officer, you can submit your requests within the scope of these rights; you can forward to our Company in writing or by using registered electronic mail (REM) address, secure electronic signature, mobile signature or your e-mail address that you have previously notified to our Company and is registered in our system.

During the application by the Data Owner, attention should be paid to the following explanations regarding the written application channels.
